3. Mayor Updates

a) TWDB Application update

Application has been submitted and now waiting for next step of the process

b) Discussion with ETMUD

Mayor Land, Alderman Terry Cole, and Alderman Gary Fox had a meeting with ETMUD about possibly considering the tie-in with them with a different agreement.

c) Extending the gas line on Hwy 16 and CR 3224 to the inner parcel of land being developed.

The city is looking into the possibility of extending the gas lines on FM 16 and CR 3224 going to the new subdivision to continue into the interior parcel of land being subdivided. The property owner is guaranteeing each new home will require at least one gas appliance. Will bring quotes of cost for extensions at a future meeting for discussion.

d) (not on agenda) Repairs needed on N Kay St going to Hwy 155 N
With new homes being built on N Kay St towards Hwy 155 N the road needs repairs for proper access to the properties being sold and/or built upon.
