3. Mayor Updates

a) Update on permits submitted for processing

There were five new permits submitted this month, all permits that have been submitted, have gone through review, and been approved. We have no pending permits at this time.

b) City trucks

We have purchased two newer trucks for the utility department. One is a 2018 Chevrolet and the other one is a 2002 Ford Ranger. Getting the lights and logos for them for use.

c) Green Science, LLC

This is a company that offers inspections for energy codes. The mayor is not recommending to use this company, she just wanted to let everyone know that this is one company available to builders in the area.

G. DISCUSSION AND ACTION ITEMS:

1. Discussion and possible action to order the election for May 2023

Alderman Dee Roden made motion to table this discussion until January meeting and seconded by Alderman Gary Fox.

2. Discussion and possible action on redoing the sign at City Hall

Mayor Pro-Tem David Beck made motion to take down the sign and redo it to the Mayor and Deana's approval and seconded by Alderman Dee Roden. All in favor; none opposed. Motion carried unanimously.

3. Discussion and possible action to approve by Ordinance a minimum square footage on dwellings brought in or constructed inside city limits.

Alderman Dee Roden made motion to set by Ordinance a minimum square foot for new single-family dwellings to 1200sqft and seconded by Mayor Pro-Tem David Beck. All in favor; none opposed. Motion carried unanimously.

4. Discussion and possible action to amend Ordinance 148 to update the verbiage to include that the home being changed out must be livable and habitable and set an age limit on it. Alderman Dee Roden made motion to update the current ordinance 148 to include an age limit of 10yrs old or newer and the home being changed out must be livable and habitable to be grandfathered in the existing ordinance 148 section 6-172 part 2 to read the mobile home is replaced with a newer mobile home of equal or greater size, is 10 years of age or newer, livable and habitable, and has not been replaced previously and seconded by Alderman Craig Attaway.

All in favor; none opposed. Motion carried unanimously.
