G. DISCUSSION AND ACTION ITEMS:

1. Discuss, consider, and adopt a resolution to designate authorized signatories for the Texas Community Block Grant program.

2. Discuss, consider, and adopt a resolution authorizing the submission of a Texas Community Block Grant program application and adopting required CDBG Civil Rights policies.

3. Discussion and possible action to adopt an ordinance amending chapter 2 (administration), article 1, section 2-1(h) (Powers and duties of mayor); Providing a severability clause; providing a repealer clause; and providing an effective date Alderman Dee Roden made motion to table for more clarification until further notice and seconded by Alderman Gary Fox.

4. Discussion and possible action to adopt an ordinance providing regulations for camping on public areas and upon private property; Implementing the requirement of a camping permit for certain camping activities; providing a severability clause; providing a penalty clause; and providing an effective date.

Add to next months meeting about AOKA dong code enforcement for condemning buildings. Alderman Terry Cole made motion to accept ordinance and seconded by Mayor Pro-Tem David Back.

5. Discussion and possible action about regulations for recreational parks.

Mayor Pro-Tem David Back made motion to designate recreational vehicle park as exempt from the 1200sqft ordinance and no tents allowed inside the park, okay to have RV's and Cabins and seconded by Alderman Gary Fox.
