F. MONTHLY REPORTS OR UPDATES:

Utility Department

Utility Supervisor Ronnie Hays was unable to attend this meeting so Mayor Curtis Land updated council on utility department standings with the gas system, water, and wastewater systems. Staff has performed maintenance at the wastewater facilities, installed vent fan in wellhouse #4, repaired chlorinator at well #5 (water tower), performed maintenance on truck fleet and equipment, repaired seven (7) water leaks throughout system, repaired four (4) gas leaks, there were thirty (30) line locates performed this month, purchased a dog kennel for the animal control facility at well #3 site, replaced three (3) meters, performed the monthly test on the emergency siren and generator located a well #5, annual inspection for natural gas insurance conducted, repaired aerator at wastewater treatment facility, removed a beaver dam at lift station, gas valves greased at Chapman Rd facility, attempt to scope with a camera known sewer mains with issues while rocks and debris prevented success, arrangements have been made with Magnum Manhole out of Dallas, TX to provide vacuum services, and read meters.
