3. Discussion and possible action to call the May 2<sup>nd</sup>, 2020 Election.

All in favor; none opposed. Motion carried unanimously.

4. Discussion and possible action to approve the purchase of a used vehicle to be used by the Utility Department at an estimated price range of \$10,000 - \$15,000. Also, approval to allow the Mayor to seek out a loan for the purchase of this vehicle.

Motion was made by Alderman Terry Cole to approve this purchase and allow the Mayor to seek out a loan and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

5. Discussion and possible action to accept the Railroad Commission agreement for settlement of \$30,000 for the fines to the city for being in non-compliance with Railroad Commission regulations.

Motion was made by Alderman Karen Hysell to approve and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

6. Discussion and possible action to approve changing from GovPayNet over to The Payment Group for credit card processing.

Motion was made by Alderman Terry Cole to approve change and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

7. Discussion and possible action to give the Mayor approval to hire for the front office position that was occupied by Darla Smith with the possibility of executive session to discuss hours and wage to pay.

Motion was made by Alderman Terry Cole to approve the Mayor and City Secretary to hire a full-time employee at \$10 per hour not to exceed 40 hour a week with benefits to begin upon completion of a 90 day probation period and seconded by Alderman Craig Attaway. All in favor; none opposed. Motion carried unanimously.
